The amended Parade Permit includes a small fee of \$50, and a fifteen day advance notice. This would be a way to get people to give us more advance notice, so we can schedule for it. Our amended permit if approved would closely mirror Juneau's parade permit.

One thought is the first time we deny a permit folks/ groups are going to be upset. Taking it to the Assembly would publicize it, let the public know about the change and give them a chance to weigh in on it.
