To Whom It May Concern,

Please consider this my letter of intent to apply for a position on the Sitka Bear Task Force.

I am the current Curator and Bear Behavior Specialist at Fortress of the Bear. I have been associated with the facility since I first came from the UK to volunteer and conduct research for my dissertation during the summer of 2012. I went on to receive a BSc in Animal Behavior at the University of Exeter.

After finishing my degree, I returned to Sitka to volunteer with Fortress for an additional two 3-month periods, then accepted an 18-month training visa. Following this, I returned to Sitka on a 3-year work visa, during which received my alien residency green card to stay in America and work permanently at Fortress of the Bear in 2018.

Including my time at Fortress of the Bear, I have approximately 12 years of experience working with bears in captivity. Through my position, I think it is very important to utilize Fortress of the Bear's resident population of bears for education. As great captive ambassadors for their species, they will be able to aid the Bear Task Force through trash-can testing and public demonstrations, while also helping provide visual aid materials that can be used for social media campaigns.
