ORDINANCE NO. 2012-12**

**AN ORDINANCE OF THE CITY AND BOROUGH OF SITKA AMENDING SECTIONS
OF SITKA GENERAL CODE CHAPTERS 19.02, 19.03, 19.09 AND 19.10, TO UPDATE
THE REFERENCE TO THE UNIFORM PLUMBING CODES AND NATIONAL
ELECTRIC CODE**

1. **CLASSIFICATION.** This Ordinance is of a permanent nature and is intended to become part of the Sitka General Code (“SGC”).

2. **SEVERABILITY.** If any provision of this Ordinance or any application to any person or circumstance is held invalid, the remainder of this Ordinance and application to any person or circumstances shall not be affected.

3. **PURPOSE.** The purpose of this ordinance is to update SGC Sections 19.02.010, 19.03.010, 19.09.010 and 19.10.010, all entitled “Adoption by reference” and SGC Section 19.03.026 entitled “2006 Uniform Plumbing Code amended,” to be consistent with State of Alaska’s adoption of the 2008 edition of the National Electric Code (“NEC”) and the 2009 edition of the Uniform Plumbing Code (“UPC”). Electrical and plumbing contractors licensed by the State of Alaska are operating under their respective codes as adopted by the State. The City and Borough of Sitka needs to interpret and enforce the same codes as those adopted by the State and utilized by the professional building community.

4. **ENACTMENT.** NOW, THEREFORE, BE IT ENACTED by the Assembly of the City and Borough of Sitka that SGC 19.02.010, 19.03.010, 19.09.010 and 19.10.010, all entitled “Adoption by Reference” and SGC 19.03.026 Entitled “2006 Uniform Plumbing Code amended” are amended to read as follows (new language underlined; deleted language stricken):


