FY14 ACWF and ADWF Intended Use Plans Questionnaires

Background

Each year, Public Works submits loan and grant applications to the Alaska Department of Environmental Conservation (ADEC) Alaska Drinking Water Fund (ADWF) and Alaska Clean Water Fund (ACWF) programs. Grants offer a 70% grant / 30% local match requirement for communities with fewer than 10,000. Two CBS projects were identified in the FY14 Governor's Proposed Budget as being eligible for funding under the Municipal Matching Grant (MMG) Program:

Public Works now wishes to submit questionnaires for the FY 2014 Intended Use Plan ACWF and ADWF loan programs for these and two other high priority project as indicated in the table below.

Analysis

Most recently, the ADEC loans have had a term of 20 years at 1.5% interest rate. The intent of Public Works is to use the ADWF and ACWF loans for the municipal match for the grants if available. However, since the above grants are not yet official until the FY 2014 budget is signed, loan amounts will be requested for the full estimated project costs. Separate loans are required for ADWF (water) and ACWF (sewer) portions of each project as applicable.

Fiscal Note

Most of the projects in which loans would be applied for through this action have been identified as top priorities in Municipal Capital Improvement Master Plans. Utilizing loans to cover the required local match on the grants, where possible, is the most prudent fiscal course of action. Current borrowing rates are very low and uncertain economic times may cause borrowing rates to increase in the future.

The cash flow from operations in the Water Fund necessary to provide for debt service coverage is currently forecasted to be \$720,000. Current debt service is \$375,000.

The cash flow from operations in the Wastewater Fund for debt service coverage is currently forecasted to be \$1,625,000. Current annual debt service is \$234,000.

For both funds, sufficient positive cash flow from operations exists in order to support additional debt. It must be noted, however, that any additional debt service will negatively impact the growth of undesignated working capital.

Recommendation:

Approve Resolution 2013-01 authorizing the City and Borough to apply for and execute loans to the Alaska Department of Environmental Conservation Alaska Drinking Water Fund and Alaska Clean Water Fund as indicated in the above table.
