This ordinance is of a permanent nature and is 13 intended to become a part of the Sitka General Code. 14 15 2. **SEVERABILITY.** If any provision of this ordinance or any application to 16 any person or circumstance is held invalid, the remainder of this ordinance and 17 application to any person or circumstances shall not be affected. 18 19 3. **PURPOSE.** The purpose of this ordinance is to add an item under the order 20 of business for Assembly agendas entitled "Board, Commission, Committee 21 Appointments and Reappointments" allowing the Assembly to recognize individuals 22 who have applied or reapplied to serve on a Board, Commission or Committee. 23 24 Historically, appointments and reappointments have been placed under the Consent Agenda and are approved by a blanket motion.
