**ORDINANCE NO. 2013-15**

**AN ORDINANCE OF THE CITY AND BOROUGH OF SITKA AMENDING  
SITKA GENERAL CODE TITLE 13 "PORT AND HARBORS" CHAPTER 13.06.010  
ENTITLED "MOORAGE CHARGES AND FEES" AT SECTION(S) G. "TOUR SHIP  
LIGHTERING FEES" AND I. "SUMMER RECREATIONAL VEHICLE/BOAT  
TRAILER PARKING FEE"**

- 1. CLASSIFICATION.** This ordinance is of a permanent nature and is intended to be a part of the Sitka General Code.
- 2. SEVERABILITY.** If any provision of this ordinance or any application to any person or circumstance is held invalid, the remainder of this ordinance and application to any person and circumstances shall not be affected.
- 3. PURPOSE.** This ordinance will increase lightering fees and the use of lightering floats as well as summer recreation vehicle/boat trailer parking fees. This increase in lightering fees, and lightering float use and vehicle boat trailer parking fees follows the recommendations of the Harbor System Master Plan and has been recommended by the Port and Harbors Commission.
- 4. ENACTMENT.** **NOW, THEREFORE, BE IT ENACTED** by the Assembly of the City and Borough of Sitka that the Sitka General Code Title 13, Chapter 13.06.010 is amended at Section(s) G. Tour Ship Lightering Fees, and I. Summer Recreational Vehicle/Boat Trailer Parking Fees to read as follows (new language underlined; deleted language stricken):

**Title 13  
Ports and Harbors**

**13.06.010 Moorage charges and fees**

G. Tour Ship Lightering Fees. The fee for the use of the lightering floats will be:

1. Nine hundred sixteen ~~Six hundred and sixty~~ dollars and seventy cents (\$916.70) per ship, per day, plus applicable city sales tax for the 2013-2006 through 2015 ~~2009~~ seasons.
2. Future lightering fees will be negotiated prior to the 2016 ~~2010~~ season.

I. Summer Recreational Vehicle/Boat Trailer Parking Fee. The rate is thirty five~~twenty~~ dollars plus applicable city sales tax per calendar day per stall.
