Introduction

I am writing to express my interest in serving on the City of Sitka's seven-member tourism commission. As a Florida transplant who has found a welcoming home in the City of Sitka. I am committed to imparting new perspectives based on seven years of experience as the Development Director for the Florida Department of State's Division of Historical Resources (DHR). As a member of DHR leadership, I helped administer resources for almost 60 downtown corridors in the statewide Florida Main Street program. This background would allow me to impart years of experience on the overall social, economic, and environmental wellbeing of our residents and wildlife here in Southeast Alaska. It would be an honor to contribute to shaping the future of Sitka's tourism industry, ensuring that initiatives benefit and respect the members of our entire community.



Organizations Which I Belong and Participate In

Currently, I serve as the executive director of the Alaska Raptor Center, a leadership role in which I have the privilege of welcoming thousands of cruise ship visitors of all ages from across the United States and other countries each year. This experience has provided me with a strong baseline for understanding Sitka's unique position as a premier tourist destination and the importance of balancing visitor engagement with the preservation of our local culture and environment. In addition, I actively collaborate with tour operators such as Alaska Coach Tours (ACT), Allen Marine, Baranof Tours, Sitka Wildlife Tours, and major domestic and international cruise line leaders to enhance the visitor experience while highlighting the best that Sitka has to offer.

My transition to Sitka has been a rewarding journey at the community level. I have joined Visit Sitka – Sitka Chamber of Commerce, and the Sitka Rotary Club, as well as the Moose and Elk Lodges. These affiliations will allow me to build strong community relationships and collaborative networks that can support the goals of our tourism commission.

Experience or Credentials I Will bring to the Tourism Task Force

Before relocating to Sitka, I helped administer the statewide Florida Main Street program, which is comprised of almost 60 local historic districts in downtown corridors. Board members ensure that the Main Street Approach focuses on Transformation Strategies, which sets intentional pathways for strengthening a downtown or commercial district's economy. Board members for each respective local Main Street community implement strategies through activities in the broad areas encompassing the Four Points, which include Economic Vitality, Design, Promotion, and Organization. Board members, volunteers, business merchants, and volunteers collaborate to implement strategies informed by market analysis, serving to guide economic programs effectively.

For example, Catalyst Strategies can focus on specific consumer segments or industry needs, such as "Family-Friendly" environments, "Arts" initiatives, or "Knowledge Economy" developments, among others. Such strategies are vital for creating dynamic and economically robust communities. In support of these initiatives, I have fundraised to enable local Main Street districts to receive training with Place Economics, a private sector firm with over thirty years' experience measuring economic impacts of historic preservation. By conducting studies, surveys, and workshops, Place Economics provides invaluable insights for downtown, neighborhood, and commercial revitalization, which helps communities make data-driven decisions based on tourism.



As of July 2024, the Main Street program facilitated three billion in private investment and over three and a half billion in public investment, resulting in almost 35,000 net jobs, 11,000 net businesses, and over 1,500,000 volunteer hours. These accomplishments exemplify the impact of collaboration and economic initiatives across multiple Main Street districts, which I hope to bring to Sitka as a collective along with other Southeast Alaska communities.

My Main Reason for Applying

An effective tourism strategy is critical for Sitka to ensure that economic benefits reach all residents while conserving our town's natural beauty and cultural heritage. My diverse experiences in community engagement and economic revitalization have equipped me with the knowledge and skills to contribute meaningfully to the tourism commission's mission.

I am applying for the City of Sitka's seven-member tourism commission out of a passion for serving the community in which I live, work, and aspire to make a tangible and intangible difference. Robust tourism offers significant opportunities for emerging economies by creating jobs, bolstering the local business owners and nonprofit organizations, and contributing to infrastructure development.
