VI. SPECIAL REPORTS: Government to Government, Municipal Boards/Commissions/Committees, Municipal Departments, School District, Students and Guests (five minute time limit)

Emergency Operation Center Incident Commander, Craig Warren told of the Covid-19 case rate increase. He conveyed how to be safe regardless of vaccination status: which was to social distance, wear a mask, and consult a healthcare provider on the vaccination. He stated that the EOC is strongly recommending masking of all Sitkans again. Dr. Bruhl, SEARHC CMO and Incident Commander stated the need for folks to get fully vaccinated. He reminded regardless of vaccination status, if someone had symptoms, they should get tested.

VII. PERSONS TO BE HEARD

Laurie Booyse, Director of Visit Sitka reported that Sitka's increase in risk levels was too high and has caused the Alaska Humanities Forum board of directors to cancel its conference that was planned for Sitka in late July. She told the Assembly that Sitka was set to welcome the first cruise ship of the season, Serenade of the Seas. She asked that the public be patient with visitors and follow precautions to keep each other safe.

Jeff Budd spoke to issues regarding public testimony and voiced concern on one person speaking on every single item. Budd suggested Assembly limit how many times a person speaks at one meeting.

Richard Wein spoke to the passing of some Sitkans. He expressed that freedom of speech and ability to speak is something he believes in and it's part of constitution.

Christianson spoke about the EOC recommendations; encouraged all to get vaccinated.

From the public, those speaking in support were: Rich Krupa, Mike Vieira, Frank Hauser, and Jeremy Strong. Speaking in opposition were: Michelle Cleaver, Lorraine Daly, Richard Wein, and Mike Daly.

Mosher thanked everyone who spoke on this ordinance and liked the idea of supporting kids. He stated that this type of business had huge expenses and spoke to the high industry tax.

A motion was made by Mosher to AMEND this Ordinance to ramp up the tax gradually, starting at 2.5% the first year and rising to the full 5% by the fourth year to give the industry time to adjust. The motion FAILED by following vote.

Himschoot said mariculture such as what was proposed at No Thorofare Bay was important, however that not enough public notice had been given to Sitkans. Christianson said he lived near Jamestown Bay and did receive notice regarding the lease but felt he was not given enough information. Nelson commented that the letter was inappropriate.

A motion was made by Himschoot to APPROVE the letter by the Municipal Administrator with the added wording: As the lessor the State of Alaska needs to assume responsibility for prevention and mitigation of potential invasive species introduction. Because of the unique qualities and high recreational value of No Thorofare Bay for the community, the City and Borough of Sitka would like to request the State to extend the comment period and provide notice to all residents through public media and posted in all harbors. The users of this bay include small boat owners of all types, but the invitation to comment was narrowed to property owners near the property proposed farmsite. The City and Borough of Sitka believes this does not capture the full scope of affected community members. The motion PASSED by the following vote.

Leach reiterated the SGC section had become a barrier to citizens for lending and insurance on homes.

Christianson didn't feel there was much input at previous town hall meetings and wished for citizens to have a chance to weigh in with an advisory vote. Knox expressed concern with the timing and how it would affect the current process for Request for Proposals (RFP) to Purchase or Lease Sitka Community Hospital Site. In addition, he wondered if citizens would approach the ballot question as a) a referendum on whether the Sitka Community Hospital business should have been sold, and b) a referendum on the organization looking to continue providing healthcare services in Sitka.

Administrator Leach explained RFP proposals were due July 28. Staff would need to review the proposals submitted, select and present it to the Assembly with a potential sales ordinance at the August 24 Assembly meeting. Municipal Attorney Brian Hanson reminded if the selected proposal was a lease, the ballot question would not be placed on the ballot. Only if the selected RFP proposal was a sale would the question be placed on the ballot. With regards to an advisory vote, Hanson said the Assembly may use the information from the electorate in their own discretion. Duncan expressed hesitation and wondered if the ballot question was brought forward due to a lack of community input from the town halls and surveys.

A motion was made by Christianson that this Ordinance be APPROVED on FIRST READING. The motion PASSED by the following vote.

A discussion of the Assembly ensued. Christianson reminded of Sitka's high case rate, noted the mandate was temporary, would expire August 24, or sooner, if Sitka's case rate dropped below high, and said the intent was for people to take the mandate and COVID-19 seriously. Himschoot, while struggling with the enforcement section, said action was needed to protect children and vulnerable adults and help decrease the high case rate. Duncan said it was important to stand together as a community and work together to bring case numbers down. She spoke to the importance of protecting those age 12 and younger who were unable to get vaccinated. Mosher spoke in support of the temporary mandate due to the highly contagious Delta variant and the responsibility to protect children. He did, however, wonder how the mandate would be implemented. Knox spoke in support although wondered if a mandate would cause some not to comply because they didn't want to be told what to do. Eisenbeisz spoke in support, wondered of enforcement, and the ability to get young children to wear a mask.

A motion was made by Christianson that this Emergency Ordinance be APPROVED on FIRST READING. The motion PASSED by the following vote.

Himschoot clarified expenses, capped at \$40,000, would be funded from the federal relief money. Duncan wondered of hotel room availability and who would inform travelers. Himschoot told of a nonprofit organization that may have room availability. Administrator Leach reminded the competitive bid process would need to be followed for securing rooms.

A motion was made by Himschoot that this Emergency Ordinance be APPROVED on FIRST READING. The motion FAILED by the following vote.

Knox and Duncan expressed hesitancy to act on the ordinance immediately.
