

Subject: Resolution Petitioning the Alaska State ABC Board for Six Additional

REPLs in Sitka

Background

Restaurant and Eating Place Licenses (REPLs) as issued by the Alaska State Alcoholic Beverage Control Board ("ABC Board") allow "bona fide restaurants" to sell brewed beverages and wine under Alaska Statute (AS) 04.09.210. Under AS 04.11.400(a), REPLs are limited to one license for each 1,500 population (or fraction thereof). According to AMCO's (Alcohol and Marijuana Control Office) 2024 population counts, Sitka has 8,063 permanent residents which allows issuance of up to 6 REPLs. Sitka currently has 8 active REPL licenses, 2 of which are seasonal REPL tourism licenses (these can only be utilized for six months out of the year and are subject to other population limits established in 3 AAC 305.310).

Under AS 04.11.405, qualifying municipalities (including CBS) may, through a resolution, petition the ABC Board to issue additional REPLs if it demonstrates and satisfies a set of requirements as set out in this statute (see Analysis). If the petition is successful, CBS will not be able to petition for additional REPLs again for one year. Our goal is to foster business opportunities for new and growing restaurants/eating places here in Sitka that can provide expanded dining options both to meet seasonal visitor demand, as well as year-round dining and employment opportunities for locals.

The Tourism Commission reviewed the draft resolution and recommended approval at its regular meeting on July 10th. Additionally, the Municipal Clerk sent an email with the draft resolution, background information, and public comment opportunities to all active alcohol license holders on July 22nd.

Analysis

In order to petition for additional REPLs, municipalities must demonstrate that it:

- Serves as a center for commercial activity within and outside its boundaries by providing goods and services to a population greater than the permanent resident population.
 - Commercial activities centralized in Sitka include seafood, health care, and tourism
 - Sitka has a visitor population of more than 665,000 (approximately 600,000 cruise visitors and 65,000 independent travelers
 - Sitka has approximately 3,200 non-local workers (3,184 in 2023)
- Maintains a local law enforcement department
- Exercises planning or land use authority
- At the time of petition, meets or exceeds the maximum limit of REPLs under the permanent resident population cap
- Would be in the public interest to grant additional REPLs
- When factoring in the permanent resident population, the visitor population, and non-local worker population, the additional REPLs requested does not exceed 1 license for each 1,500 population
 - With 6 additional REPLs, the resulting ratio would be 1 license for each 48,303 population.

Staff reviewed recent REPL petitions from other Alaska municipalities – since 2023, petitions from Juneau, Homer, Haines, Soldotna, Wasilla, and Valdez have been approved. Our request for 6 additional REPLs puts our license to population ratio squarely between Juneau's post-petition ratio (1 per 54,511) and Haines' post-petition ratio (1 per 35,215) which we believe is reasonable and defensible given our size relative to the two communities, and other similar factors such as the nature of our visitor industries and geographic isolation.

Fiscal Note

No expenditures are associated with this resolution outside of staff time to submit the resolution/petition materials and (virtually) attend the September 16th ABC Board meeting at which the petition will be considered.

While difficult to estimate, there are additional revenue opportunities for CBS associated with this resolution, primarily increased sales tax from new/expanded restaurants which are able to secure new REPLs.

Recommendation

Approve the resolution and submit it to the ABC Board for consideration/approval.

CITY AND BOROUGH OF SITKA 1 2 3 **RESOLUTION NO. 2025-11** 4 5 A RESOLUTION OF THE CITY AND BOROUGH OF SITKA PETITIONING THE ALASKA STATE ALCOHOLIC BEVERAGE CONTROL BOARD TO 6 ISSUE UP TO SIX ADDITIONAL RESTAURANT OR EATING PLACE LICENSES UNDER 7 8 ALASKA STATUTE (AS) 04.11.405 9 WHEREAS, the City and Borough of Sitka (CBS) is incorporated as a home rule municipality and is 10 eligible to seek additional Restaurant or Eating Place Licenses (REPL) from the Alaska 11 State Beverage Control Board through the process outlined in Alaska Statute ("AS") 12 04.11.405; and 13 14 WHEREAS, Sitka serves as a hub of regional commerce in Southeast Alaska due to its strategic 15 location, established fishing and seafood industry, role as a service center, and its 16 expanding healthcare and tourism sectors; and 17 18 WHEREAS, approximately 8,063 people live in Sitka year-round, Sitka employs approximately 3,200 19 non-local workers and has over 665,000 yearly visitors; those workers and visitors rely 20 on CBS for goods and services meeting the requirements outlined in AS 21 04.11.405(b)(1)(A); and 22 23 24 WHEREAS, the Sitka Police Department has 7 sworn peace officers and numerous other staff members to provide local law enforcement services including police patrol and criminal 25 investigation, meeting the conditions outlined in AS 04.11.405(b)(1)(B); and 26 27 WHEREAS, the CBS Planning Commission and the Planning and Community Development 28 Department are tasked with wide-ranging planning and land use authority including, but 29 not limited to, zoning regulation and oversight, management of CBS lands, and updates 30 to the CBS Comprehensive Plan, meeting the conditions outlined in AS 31 04.11.405(b)(1)(C); and 32 33 WHEREAS, the CBS currently exceeds the maximum number of REPL licenses allowed under AS 34 04.11.040(a) with 8 active licenses, meeting the conditions outlined in AS 35 04.11.405(b)(1)(D) and (c)(3)(B); and 36 37 WHEREAS, when considering the cumulative number of year-rounds residents, non-local workers, 38 and annual visitors, the total resulting population is well above the additional population 39 that would be required for the 6 additional licenses requested to maintain the 1 to 1,500 40 ratio mandated under Title 4, meeting the conditions outlined in AS 04.11.405(c)(4); and 41 42 WHEREAS, expanding the availability of beer and wine sales to additional local restaurants would 43 enhance dining options for both residents and visitors, while also supporting the growth 44 and diversification of Sitka's small business community and related employment 45 opportunities. 46 47
