The Mayor read a proclamation recognizing John J. and Eleanor A. Brust & Family for their recent donation to the Library.

VI. PERSONS TO BE HEARD

City Assessor, Randy Hughes, reminded folks of the upcoming exemption deadline February 15th.

Dan Stockel spoke against allowing short-term rentals in residential zones.

Michelle Putz noted her efforts to carpool, thanked High School students for their energy conservation efforts, and said she would be working on placing a permanent place holder on the agenda to address strategic planning.

Shaina Kilcoyne, Energy Efficiency Director with REAP (Renewable Energy Alaska Project) addressed the Assembly and shared ways in which REAP was promoting renewable energy and efficiency.

IX. UNFINISHED BUSINESS:

D ORD 13-01

Authorizing the issuance of harbor facilities revenue bonds in the principal amount of not to exceed \$4,600,000 to finance a portion of the cost of certain capital improvements to Sitka's harbor facilities; authorizing the sale of the bonds to the Alaska Municipal Bond Bank on the terms and conditions provided in this ordinance and in a loan agreement authorized to be entered into with the Bond Bank; and providing the terms and conditions for issuing additional harbor facilities revenue bonds on a parity with the bonds authorized by this ordinance

Hunter wondered if a future sale of the Marine Service bulkhead would pose a problem. Municipal Attorney Hillhouse noted the City's bond counsel stated it would not be an issue.

A motion was made by Christianson that this Ordinance be PASSED ON SECOND READING. The motion PASSED by the following vote.

E ORD 13-02

Authorizing the issuance of junior lien electric revenue bonds of the City in the principal amount of not to exceed \$45,000,000 to finance a portion of the cost of expanding the Blue Lake hydroelectric project; and authorizing the sale of the bonds to the Alaska Municipal Bond Bank on the terms and conditions provided in this ordinance

Rusty Sutton, Matt Donohoe, and Valorie Nelson spoke in opposition to the ordinance. Andrew Thoms spoke in favor of the ordinance. Vaughn Hazel voiced questions regarding the ordinance.

Utility Director, Chris Brewton, stated the Blue Lake Dam expansion project was a viable project and important to the future of Sitka.

Assembly members offered their comments.

A motion was made by Reif that this Ordinance be PASSED ON SECOND READING. The motion PASSED by the following vote.

Amending Sitka General Code Title 4, Chapter 9 entitled "Sales Tax" and making corresponding changes in Sitka General Code Title 4, Chapter 24 entitled "Hotel, Motel and Bed and Breakfast Transient Room Tax"

Rusty Sutton wondered how this ordinance would affect tourism and taxes. The

Assembly stated this ordinance would not increase taxes; it was a housekeeping measure.

Hackett thanked the Finance Department for their work.

Connor Nelson spoke in opposition to the Ordinance.

Public Works Director, Michael Harmon, and Municipal Attorney, Theresa Hillhouse, explained the Ordinance; an authorization of a lease amendment with Southeast Earthmovers, Inc. for Granite Creek Site 5.

Reif explained his reason for cosponsoring. Reif asked Public Works Director, Michael Harmon, to come forward and give examples of when the sinking fund would be beneficial to have: transition of heating systems to heat pumps, parks, streets, and facilities.

A discussion ensued among Assembly members.

Connor Nelson stated the money in the sinking fund should be spent now while it was worth something.

Ryan Kauffman spoke in support of the Ordinance.

A motion was made by Hackett to POSTPONE this Ordinance to the February 12th Assembly meeting. The motion FAILED by the following vote.

Valorie Nelson, Matt Donohoe, and Rusty Sutton spoke in opposition to the Ordinance.

Mayor McConnell noted this Ordinance, if passed, would go into effect July 1, 2013.

Utility Director, Chris Brewton, stated the 15% rate increase was required to meet the bond covenants.

A motion was made by Christianson that this Ordinance be PASSED ON FIRST READING. The motion PASSED by the following vote.

Discussion/Direction to select a Municipal Attorney applicant(s) for in-person and/or telephone interviews with the Assembly, and schedule interview dates(s), time(s) & location(s).

Mayor and Assembly members discussed how they wished to proceed. It was determined to hear from Ms. Hillhouse and Mr. Danielson and what they may have to offer on the candidates. First, they removed four candidates who did not meet the minimum qualifications. They then discussed whether to interview local candidates and decided to, only if the candidates were among the Assembly's top choices. Each Assembly member then offered up their top choices.

A motion was made by Hunter to make arrangements to interview Allen Bell and Robin Koutchak. The motion PASSED by the following vote.
