ORDINANCE NO. 2011-13

AN ORDINANCE OF THE CITY AND BOROUGH OF SITKA REPEALING SITKA GENERAL CODE CHAPTER 4.16 ENTITLED "FUEL FLOW TAX" AND CHAPTER 11.58 ENTITLED "FOR HIRE VEHICLES AT THE SITKA AIRPORT"

1. **CLASSIFICATION.** This ordinance is of a permanent nature and is intended to become part of the Sitka General Code ("SGC").
2. **SEVERABILITY.** If any provision of this ordinance or any application to any person or circumstance is held invalid, the remainder of this ordinance and application to any person or circumstance shall not be affected.
3. **PURPOSE.** The purpose of this ordinance is to repeal SGC Chapter 4.16 entitled "Fuel Flow Tax" and Chapter 11.58 entitled "For Hire Vehicles at the Sitka Airport." These chapters were put in place when the City and Borough of Sitka operated the airport. However, on June 1, 1997, the City and Borough of Sitka entered into a new lease agreement with the State of Alaska in which the City and Borough of Sitka only owns and operates the terminal building while leasing the terminal building land from the State of Alaska. The City and Borough of Sitka no longer operates the airport or any other functions of the airport except the terminal building. Therefore, both these code chapters are no longer enforceable and should be repealed.
4. **ENACTMENT.** NOW, THEREFORE, BE IT ENACTED by the Assembly of the City and Borough of Sitka that SGC Chapter 4.16 entitled "Fuel Flow Tax" and Chapter 11.58 entitled "For Hire Vehicles at the Sitka Airport" are repealed (new language underlined; stricken language deleted):

FUEL FLOW TAX

~~A. A tax is levied on all motor fuel as defined in AS 43.40.100(a), and all other aviation petroleum products which are dispensed into aircraft at the Sitka Airport.~~

~~B. The tax is two cents per gallon.~~

~~C. The distributor shall be responsible for collecting the tax from the consumer. If the distributor has reasonable cause to believe that fuel sold is ultimately destined to be dispensed to an aircraft at the Sitka Airport, he shall require the customer to pay the tax at the time of the sale or cause the customer to sign a statement that the fuel is not going to be dispensed into an aircraft at the Sitka Airport.~~

~~D. It shall be a misdemeanor to falsely sign or cause to sign, such a statement or to do so with false intent. The maximum fine shall be five hundred dollars.~~

~~Section 3 and Section 4.d of the rules and Regulations for Operation of Air Terminals shall govern use of the airport by taxis, limousines, and buses including fees for such use.~~


~~11.58.020 Penalty.~~

~~A.—Operation of “for hire” vehicles at the Sitka Airport without a permit is a violation which shall be punished by a five hundred dollar fine.~~

~~B.—Failure to pay the monthly fee shall result in forfeiture of the violating company’s permit for one year.~~

5. **EFFECTIVE DATE.** This ordinance shall become effective the day after the date of passage.
