This ordinance is of a permanent nature and is 15 intended to become a part of the Sitka General Code. 16 2. **SEVERABILITY.** If any provision of this ordinance or any application to 17 any person or circumstance is held invalid, the remainder of this ordinance and 18 application to any person or circumstances shall not be affected. 19 20 3. PURPOSE. The purpose of this ordinance is to add a membership category 21 22 entitled "alternate member" to the Sitka Investment Committee. The Committee member shall be appointed by the Assembly and serve a three year term. Currently the 23 24 Committee consists of three members and at times has had difficulty obtaining a quorum. Adding a fourth voting member that will fill in for an existing member in his or 25 her absence should address the issue. 26 27 4. ENACTMENT. NOW, THEREFORE, BE IT ENACTED by the Assembly of 28 the City and Borough of Sitka that Chapter 2.62.010 of the Sitka General Code is 29 amended to read as follows: 30 31 Title 2 32 Administration 33 34 Chapter 2.62 **Sitka Investment Committee** 35 36 Section 2.62.010 Established - Membership - Terms. 37 38 There shall be established a committee to be known as the Sitka investment 39 committee which shall consist of three four members with one member serving as 40 an alternate voting member who shall serve terms of for three years terms. The 41 city and borough finance director shall be an ex officio member of this 42 43 committee. All committee members shall be appointed by the assembly. and the first Sitka investment committee members shall be appointed and serve terms as 44 follows: 45

A. One member for a term of three years;
