#### RESOLUTION NO. 91-472

#### A RESOLUTION OF THE ASSEMBLY OF THE CITY AND BOROUGH OF SITKA PROVIDING FOR THE ESTABLISHMENT OF THE SITKA ADVISORY COMMISSION ON AGING

WHEREAS, it is the policy of the City and Borough of Sitka to promote programs which benefit senior citizens of Sitka by enhancing their health, safety and welfare and to promote maximum senior citizen participation in planning, development, operation and maintenance of such programs; and

WHEREAS, several committees, groups and persons are now involved in local programs and services for senior citizens without clear definition of inter-relationships and responsibilities among the various entities; and

WHEREAS, effectiveness and efficiency in functions could be improved by specific identification and assignment of functions and responsibilities for each entity as well as the relationship of each entity to others and to the staff and Assembly of the City and Borough of Sitka; and

WHEREAS, plans, programs, budgets, staff, support facilities and property management functions as well as current and proposed contractual relationships affecting the senior citizens of Sitka are central and of utmost concern to the senior citizens of Sitka.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY AND BOROUGH OF SITKA, ALASKA that:

- 1. There is established the Sitka Advisory Commission on Aging which shall consist of a cross-section of seven members who shall be appointed by the Assembly for three-year staggered terms beginning on July 1, except those first appointed shall be for terms of one, two, and three years as designated by the Assembly. At least four members shall be 65 years of age or older.
- 2. The powers and duties of the Sitka Advisory Commission on Aging may include but not necessarily be limited to the following:
- (a) To promote programs which benefit and/or enhance health, safety and welfare of senior citizens.
- (b) To promote maximum senior citizen participation in planning, development, operation and maintenance of facilities, services and programs designed to serve senior citizens principally.
- (c) To serve as a focal point for coordination of senior citizen functions among the several committees, subcommittees, task groups, the city administrator, and the Assembly of the City and Borough of Sitka.
- (d) To review and make recommendations upon plans, programs, budgets, staff, property and support facilities, management functions, and contractual relationships affecting the senior citizens of Sitka and report findings directly to the Assembly.
- (e) To formulate and recommend to the Assembly a comprehensive areawide plan that identifies the concerns and needs of older Sitkans.
- (f) To collect facts and statistics, and make studies of conditions and problems pertaining to the employment, health, financial security, social welfare, and other concerns that bear upon the well-being of older Sitkans.

- 3. The commission shall select its own officers, and shall hold regular meetings on a schedule established by the commission as well as such special meetings as required to conduct business.
- 4. The commission shall not lobby nor take an advocacy position as a municipal commission without specific prior Assembly approval.

A RESOLUTION OF THE ASSEMBLY OF THE CITY AND BOROUGH
OF SITKA, ALASKA, CONVERTING THE SITKA ADVISORY COMMISSION ON
AGING, ESTABLISHED UNDER RESOLUTION 91-472, TO THE SITKA ADVISORY
COMMISSION ON HEALTH NEEDS AND COMMUNITY SERVICES

WHEREAS, in 1991, the Assembly created the Sitka Advisory Commission on Aging to promote services for the elderly, coordinate services to senior citizens, and advise the Assembly on senior citizens' issues; and

WHEREAS, the Sitka Advisory Commission on Aging has recommended that its focus be enlarged to encompass community services and health needs and that it be renamed to reflect that change in focus;

**NOW, THEREFORE, BE IT RESOLVED** by the Assembly of the City and Borough of Sitka, Alaska that:

- 1. The Sitka Advisory Commission on Aging is re-designated the Sitka Advisory Commission on Health Needs and Community Services.
- 2. The commission shall consist of seven members appointed by the assembly to staggered three-year terms, two members shall be 65 years of age or older. The initial commission will consist of the present members of the Sitka Advisory Commission on Aging, serving the terms for which they were appointed, plus any new appointees needed to complete the commission.
- 3. The powers and duties of the Sitka Advisory Commission on Health Needs and Community Services shall include, but not necessarily be limited to the following:
  - (a) To promote programs and community services which address the health needs and/or enhance the health, safety, and welfare of the citizens of Sitka.
  - (b) To promote maximum citizen participation in the planning, development, operation, and maintenance of facilities, community services, and programs designed to address the health needs, safety, and welfare of the citizens of Sitka.
  - (c) To serve as a focal point for coordination of health needs and community services among the various committees, the administrator and the Assembly of the City and Borough of Sitka.
  - (d) To help formulate and recommend to the assembly a comprehensive area-wide health needs and community service plan.
  - (e) To collect facts and statistics, and make studies of the community services and health needs in the City and Borough of Sitka.

4. The commission shall select its own officers and shall hold regular meetings on a schedule established by the commission without specific prior Assembly approval.
