Doug and Garry,

Due to serious issues and concerns raised here and by numerous other citizens, I feel compelled to suspend all further street closures until this issue can be addressed by the Assembly. The next Assembly meeting will be June 25.

As I have already stated, the downtown revitalization effort is NOT a mission or directive of the Municipality; the Assembly has not directed Staff to organize, manage, or oversee the street closures. It has also not publicly discussed the issue of street vendor sales during these events. Until such specific direction occurs from the Assembly, the Municipality is not going to involve itself in setting rules and guidelines for street sales. To do so would involve judgment calls on public policy that are the purview of the Assembly.

As the Assembly does not meet again until June 25, I am going to ask the Police Department to suspend all future street closure permits until the Assembly gives direction on this matter.

Jay,

Below is SGC concerning sales on public property, specifically CBD District. Sales on public property are prohibited. 6.16.010 (C) gives the Administrator authority to allow sales. If you have not done so, then no one should be on public property selling items.

If you have given authorization to sell on public property, then I would assume sales are open to everyone as it is public property.

If you are only allowing the DT revitalization group to conduct sales on public property, then I have a real issue with that as well as all other merchants in the community.

In my opinion it is either no sales on public property or everyone is allowed. If everyone is allowed, then some rules need to be established or it will turn into what happened a few years ago with excursion vendors and cruise passengers, ask Stan and Don about that.

Except as allowed in this section, outdoor sales of goods or articles, including solicitation for certain services or activities, are prohibited outdoors on public property in the CBD district, public use zone and public boat harbors. This prohibition includes, but is not limited to, sales on public sidewalks, parking lots and streets, except as allowed below:

- A. The following sales will be allowed in areas designated on an annual permit issued by the municipality for a fee of ten dollars:
 - 1. Incidental sales by juveniles of Alaskan items made by the juveniles, or natural items collected by the juveniles, to tourists in the Crescent Harbor area,
 - Traditional sales of Alaskan items by Alaska Natives.
 - Sales of personally made arts and crafts items by senior citizens for charitable purposes, 3.
 - a. Sales of items by juveniles, the proceeds from which will primarily benefit a recognized charitable organization dedicated to providing programs for youth.
 - Sales will be limited to unique items that are not available commercially,
 - c. Such permits shall be limited to no more than three groups at any one given time;
- B. Retail sales of seafood to the ultimate consumer by the actual fisherman from their vessels in the assigned stalls:
- C. By prior arrangement with the administrator, sales may be authorized for special events such as the Salmon Derby, the Fourth of July and Alaska Day;
- D. Solicitation by musicians shall be allowed in areas designated on a musician permit issued by the municipality for an annual fee of ten dollars, under the following conditions:
 - 1. Musician may perform and will be issued a musician permit during hours designated by the harbormaster, and
 - No electrical amplification of any instrument will be allowed;
- E. On-site supervision by an adult is required for all juveniles under the age of ten who participate in permitted sales and other activities allowed under this section. The permit may be revoked for misconduct;
- F. Failure to follow the rules of this chapter may result in the loss of a permit.

Hello Garry,

I am maintaining a firm stance that downtown revitalization, and its associated activities, is not a formal mission or responsibility of the City and Borough of Sitka at this point. For the Municipality to officially take this responsibility on, the Assembly would need to direct staff to organize and implement the beautification/revitalization, which it has not done.

At this point, the Municipality is a supporting the ad hoc Downtown Revitalization Committee with limited financial and logistical support, as requested by the Committee and as appropriate. The Municipality advised as to what can't be accomplished because of law, SGC, or private property issues; otherwise, the Municipality attempts to coordinate the desires of the Committee.

Given this, the role of the Municipality in regards to street closure is to process the closure permits (which has been done), erect the barricades, and monitor the closure safety-rtelated issues and compliance with other civil code requirements.

Thus, the source of answers for your questions is the ad hoc Downtown Revitalization Committee. Doug Osborne is the Committee Chairman/Spokesman, and he is the individual you should direct your comments and questions to.

If the street closure can't be accomplished successfully through the efforts and management of the ad hoc Committee, and the responsibility falls back onto the Municipality to manage the event, I will have to give strong consideration to suspending further closures until the Assembly can weigh in on the matter at its next meeting.

The decision on how to proceed was left completely to the group and they decided not to pull the plug, they see the potential and I support their decision.

While the very ugly "uptown merchants vs downtown merchants" quarrel has raised it's head again (lightering boats) to cause Mr. Sweeney to temporarily suspend the downtown Lincoln Street "open mall", I don't believe that should be the deciding factor.

The State of Alaska DOT has been collecting traffic data for years. The link below is pointed to their 2011 data for the downtown Sitka Area. The numbers in red are the average DAILY traffic counts. When you find the Lincoln Street number you will see it says 6,359 daily traffic counts. Yes, 6,359. Here is the average daily traffic count.


Definitions:

Annual Average Daily Traffic (AADT): The estimated number of vehicles traveling over a given road segment during one 24 hour day. In practice, AADT is usually obtained from a sample(coverage count) adjusted for seasonality assuming roads are open year round.

If you were downtown during the closure you would have seen the multiple vehicles making circles around the St. Michael's Church, even with the notification. All these people inconvenienced by the closure include probably thousands of local residents, hundreds or more of local non-tourist vehicle traffic, who knows how many public service vehicles, including police and fire. Oh yeah, the tour buses had to re-route too.

with the exception of the HPR and Sawmill Creek Road systems, Lincoln Street has the highest traffic. Lincoln Street is our "Main Street". And the traffic numbers show that. This data alone should be enough to permanently suspend the revitalize "

I am very happy to share my town with cruise visitors. I understand that they are a main source of revenue to our city. However, there are many people who do not share those same feelings. Unfortunately, closing the street to through traffic will not help those folks accept the cruise visitors with any more positive feelings. As I said, I am happy to share my town. I enjoy the visitors. But, I also do not want to inconvenience the local population unduly. I believe that closing Lincoln Street does just that. This will only be viewed as a negative. Cyndy Gibson of the Revitalize Sitka's apology in tonight's paper for not doing a better job of informing the community about the event – continues to show the lack of organization by this lofty group to do good, consideration of ALL-OF-SITKA the right of access 24/7/365 and the on-going request from Assembly members (May 28th meeting), merchants and residents, to give the group an opportunity to submit a detailed proposal that measures success or failure when closing off Lincoln Street on one of its busiest days of the summer season – before it happens. I know for fact the group has been planning this since January and I would consider Wednesday's efforts – lack luster at others expense!

No matter how much free marketing/advertising space the Sentinel is giving this group to succeed and the mention of street closures on four consecutive Wednesdays, obviously the group didn't make phone calls and work one-on-one with transportation logistics! I witnessed first hand when the supervisor from STA and Community Ride comes upon Lincoln Street street closure at 7:00 AM and learns of it for the first time. She was not happy and rightfully so. Besides preparing for the arrival of the cruise ship, her office now has to re-route the Community Ride buses and ridership for the day.

I get a sense that the group kept things low-key to avoid a public outcry. Not alerting transportation and police to work out logistics is unforgiveable. The group didn't take into consideration the ripple affect beyond the 200 block of Lincoln as traffic congestion built back on Lincoln, Lake and Sawmill Creek as well as Jeff Davis – as the Police Blotter duly noted.

From every angle of this event, I only viewed 4 people taking the advantage of extra space and set up a table to sell 'more stuff' – in an attempt to enhance the local experience. Did they have a permit? Did the group charge a high price on the table rental? Why didn't the City charge a usage fee for this valuable piece of real estate? Merchants can't complete with FREE.

Had this group worked hard on this effort, there would have been street artists and vendors, staffing from Chamber and Visitor Center (lodges, operators, attractions) and Historical Sitka group taking the advantage of showcasing Sitka – with all that we have to offer - would have filled the days activity. The only novelty was the visitor who stood in the middle of the 200 block of Lincoln and took photographs of our crown jewel, St. Michael's and lots of open space for a few to enjoy.

Because the group did not establish and publish their a measurement of success or failure i.e. what did they hope to achieve from the perspective of something different than a mall-like atmosphere, if ongoing what the income and expense would be realized by group organizers, how does a rainy day keep the people sitting in the lawn chairs and enjoying the local experience, how were the merchants receipts Wednesday June 5th, vs. June 12th, 19th, 26th and July 10th – it remains confusing for City Officials to approve future closures? How were tour operators compensated for their expense.

In summary, in my opinion, the City officials has to quickly take charge of any future street closures and become more participatory with guidelines and regulations and not let the 200 block of Lincoln become free-rent space for event planners and exhibitors.

The next thing I would recommend is to think twice at giving the \$25,000 to this ad hoc committee because the City already has the various Boards and Commissions who volunteer their expertise to recommend and follow-though with annual downtown clean up, work with business owners to beautify (planters, murals and art), and make it a tradition that as the Christmas light fixtures come down, banners automatically are hung in spring and fall.
