Application to serve on the Bear Working Group

I respectfully request your consideration and consent to serve on the Bear Working Group. My residence is 508 Hirst St.. Over the past three years our neighborhood has gone from infrequent, passive visitation by bears to where I have cleaned up three different piles of other people's refuse from bear activities. Two years ago I retrieved a 20mm sabot projectile in my back yard (used to haze bears in confined locations).

I personally do not place my garbage outside until the day of garbage collection. Never underestimate the olfactory senses of wildlife, especially bears.

I have had numerous encounters with bears, on the fringe of town (acclimated to mankind) to those that are truly wild. Four years ago, I fended off a disturbed sow with two-year-old cubs with a walking stick. I know what bears smell like and have had black bears chomp their teeth as a threat to my presence. I admire and respect the animals. It is disturbing to be off trail and find bear fecal matter mired with plastic disposable gloves, yogurt tops and shards of white garbage bags, rather than composed of berries, skunk cabbage or phew, salmon poop.

We have to address the "bait" that lures the opportunistic creatures into our neighborhoods. We humans have to change our habits in concert to be successful.
