**Subject:** Reassignment of Granite Creek Lease Area 2 and 3

### **Background**

In December of 2021 the City and Borough of Sitka (CBS) publicly advertised a Request for Proposal (RFP) to solicit bids for a mineral extraction lease at Granite Creek Lease Areas 2 and 3.

By January of 2022, the RFP solicitation for Granite Creek Lease Areas 2 and 3 closed. Though the solicitation period for the RFP was open for approximately one month, the solicitation yielded only one respondent, McG Constructors Incorporated (McG). In October of 2022, CBS entered into a 5-year lease agreement with McG for the advertised lease areas.

In April of 2023, citing the unfortunate passing of a principal member of the lessee's business operations, McG formally requested consent from CBS to reassign the role of lessee from McG to Colaska/SECON.

## **Analysis**

In consideration of providing consent to reassign this lease to the proposed candidate lessee, the CBS has evaluated several key areas which could carry potential for risk. Key areas of evaluation focus around verification of good-standing status with regulatory bodies and good-standing with past and current financial engagements with the CBS for both parties.

**Financial Compliance** – As of the date of this evaluation, both McG and SECON are in good financial standing with the CBS. McG has paid all due royalties that are associated with the existing lease and has made timely lease payments throughout the existing lease. Additionally, Colaska/SECON has paid all due lease payments during their existing lease at the Granite Creek Lease Site 7.

**Safety Compliance** – As of the date of this evaluation, both McG and Colaska/SECON are in good standing with the Federal Mine Safety and Health Administration (MSHA) and do not have any outstanding violations.

**Environmental Compliance** – As of the date of this evaluation, both McG and Colaska/SECON are in good standing with the Alaska Department of Environmental Conservation (ADEC) and do not have any outstanding Multi-Sector General Use Permit (MSGP) violations.

# Fiscal Note

There are no proposed changes to the financial terms of the lease and therefore no financial impact related to the assignment of this lease.

### **Recommendation**

Following the evaluation of key risk areas associated with providing consent to reassign the lease from McG to Colaska/SECON, it is recommended that the CBS provide consent to reassign the lease. It is further proposed that all lease terms and conditions remain the same as the initial lease that was assigned to McG.

Secon has an adjoining lease area in the Granite Creek quarry. Secon's willingness to take over the lease on these areas 2 & 3 makes sense due to this fact.

Secon operates and maintains 7 separate Mine IDs throughout Southeast Alaska. Each is eligible for 2 annual MSHA site inspections when active. Workload throughout our region determines what sites will be active and for what duration. MSHA has an online reference to determine mine operators' compliance with the agency, and what citations have been issued to that quarry in the past. Secon has and will continue to comply with regulations enacted to protect our miners employed at our sand and gravel quarries. We operate under an MSHA approved training plan that requires an initial 24-hour classroom-based introduction to mining hazards to entry level employees, and 8 hours of annual refresher training to our experienced miners.
