

#### SUPPLEMENTAL ESSAY QUESTION

 What have you learned about the City and Borough of Sitka that makes you interested in this position, and why is now a good time in your career to consider this position? If selected for this position, are you fully committed to relocating to Sitka?

I appreciate these questions for several reasons. I am a senior attorney with 26+ years of experience in Alaska and, to a small extent while in law school, Colorado. After my clerkship on the Alaska Court of Appeals, I joined a well-established local law firm where my practice focused on education law. In that role, I was fortunate to travel throughout rural Alaska serving local school boards and participating in public processes. I then joined a large Pacific Northwest law firm, where I was able to focus on advising Alaska Native Corporations and nonprofit organizations, Tribes and Alaska businesses in all manners of business, corporate and real estate transactions, employment matters and board governance. After maintaining my private practice during COVID, I felt the call for public service, so I joined the Municipality of Anchorage's legal team, serving as a line attorney and Acting Deputy Municipal Attorney. I currently serve as a line attorney and Acting Municipal Attorney on several matters.

When the position of Municipal Attorney for the City and Borough of Sitka came to my attention, I felt compelled to apply. First, as a senior attorney, I would like the next stage of my career to be in a leadership role, practicing in areas where I have developed expertise and sound judgment. Second, my husband and I would enjoy living in a smaller, close-knit community, and I suspect that Sitka would suit us well. We like to be near the water, and my husband's business of shrink wrapping boats could serve the area. My family has close ties to Sitka, and I grew up hearing many stories about Sitka. My mother, Ida Traeger, was the first Alaska Native from Unalakleet, Alaska to attend high school out of the village. She attended what was then Sheldon Jackson High School, graduating in 1950. One of my sisters graduated from what was then Sheldon Jackson Community College. While we would maintain our small condo in Anchorage for rental reasons, we are fully committed to relocating to Sitka, pending a visit and selection of housing.

This is a good time in my career to consider this position. I have the experience and judgment, am knowledgeable about Alaska Native and governmental affairs, and am committed to serving the public interest. Thank you for considering my application.
