Subject: Reappropriation of Unspent FY2025 Budget Items

Background

While staff generally spend down or have funds under contract in the fiscal year in which they were budgeted, in some cases that is not possible. There are two requested FY2025 reappropriations:

- 1. Funding of \$120,000 was included in the FY2025 budget for repairs at Whale Park. However, with other projects taking priority, procurement for this work was not completed by June 30, 2025. If approved, the repairs are expected to be completed in winter/spring 2026.
- 2. CBS was awarded a Homeland Security grant in FY2025 (approved by the Assembly on May 29, 2025). The grant includes \$12,096 of funding for travel and training that will not occur until later in FY2026.

It is also important to note that some FY2025 efforts are still underway. Any funds that were contractually committed but not yet spent will automatically carry forward to FY2026 in accordance with Charter Section 11.12. A summary of these unspent commitments, supported by contract and/or purchase order is attached. Totals are preliminary, as invoices for work completed in FY2025 may still be submitted and processed.

Analysis

The requested reappropriations listed below are critical expenditures that staff are actively working on but were unable to finalize commitments before June 30, 2025. Mechanically, the FY2025 budgets are decreased and the FY2026 budgets are increased.

Fiscal Note

The total change (decrease to FY2025 budget and increase to FY2026 budget) for reappropriation of funding from FY2025 to FY2026 is \$132,096. In addition, the purchase orders entered for existing encumbrances will also reduce the FY2025 appropriations and increase the FY2026 appropriations.

ORDINANCE NO. 2025-23 AN ORDINANCE OF THE CITY AND BOROUGH OF SITKA MAKING SUPPLEMENTAL APPROPRIATIONS FOR FISCAL YEAR 2025 and 2026 (Reappropriations)

BE IT ENACTED by the Assembly of the City and Borough of Sitka, Alaska as follows:

- 1. **CLASSIFICATION.** This ordinance is not of a permanent nature and is not intended to be a part of the Sitka General Code of the City and Borough of Sitka, Alaska.
- 2. **SEVERABILITY.** If any provision of this ordinance or any application thereof to any person or circumstance is held invalid, the remainder of this ordinance and application thereof to any person and circumstances shall not be affected thereby.
- 3. **PURPOSE.** The purpose of this ordinance is to make supplemental appropriations for Fiscal Year 2025.
- 4. **ENACTMENT.** In accordance with Section 11.10(a) of the Charter of the City and Borough of Sitka, Alaska, the Assembly hereby makes the following supplemental appropriations for the budget period beginning July 1, 2024, and ending June 30, 2025 is hereby adjusted as follows:
