CLASSIFICATION. This ordinance is not of a permanent nature and is not 12 intended to become a part of the Sitka General Code (SGC). 13 14 2. SEVERABILITY. If any provision of this ordinance or any application to any 15 person or circumstance is held invalid, the remainder of this ordinance and application to any person or circumstance shall not be affected. 16 17 18 3. PURPOSE. The purpose of this ordinance is to facilitate the lease of 19 approximately 1.463 acres of municipally owned tidelands referred to as Alaska 20 Tidelands Survey No. 580, Plat 2007-19, located seaward of 2309 Halibut Point Road, 21 to Evergreen Properties, LLC, for use by the lessee as a mobile home park. 22 23 4. ENACTMENT. NOW, THEREFORE, BE IT ENACTED by the Assembly of the City and Borough of Sitka. 24 25 26 A. The leasing of Alaska Tidelands Survey No. 580, Plat 2007-19, consisting of 27 approximately 1.463 acres is hereby authorized with the following terms: 28 1. The term of the lease is for thirty (30) years. 29 2. The annual lease payments shall total \$6,391.00 per year, plus applicable 30 sales tax, and shall be adjusted each year. 3. As the applicant is the upland property owner, competitive bid is 31 32 inappropriate. 33 4. The Lessee shall use the leased property exclusively as a mobile home 34 park. The Lessee shall not use the leased property or any portion of it for 35 a different purpose without prior written approval by the Assembly. 36 37 B. The Administrator is authorized to execute a lease document consistent with 38 the terms of this ordinance, SGC Title 18 that governs municipal leases, and 39 existing municipal policies. 40 41 C. The Assembly has found that the requirement to competitively bid leases of 42 municipal real property as outlined by SGC 18.15.010(E) is inappropriate due 43 to the location of the parcel which renders it of true usefulness to only one 44 party, the upland property owner. 45 46 5. **EFFECTIVE DATE.** This ordinance shall become effective on the day 47 after the date of its passage.
