Will Peterson, President of the Sitka Community Land Trust (SCLT), provided a summary of SCLT's work over the last 18 months and invited the public to the S'us' Héeni Sháak Community Neighborhood dedication on May 13. Samantha Matthews with the Pardee RAND Graduate School, announced the findings of their Sitka Community Assessment on Tourism, a partnership project with the Sitka Sound Science Center.
