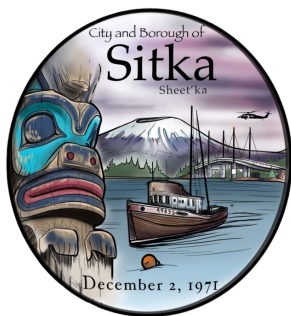

The Municipal Clerk's Office has received notification from the Alcohol and Marijuana Control Office of the new liquor license endorsement application below:

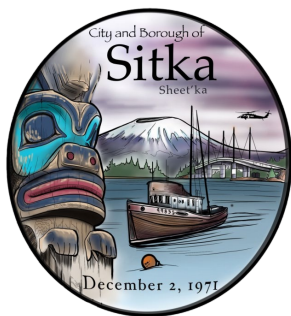
