#### **Background**

Blatchley Middle School (BMS) is currently undergoing the significant remodel and/or replacement of the school's existing mechanical and electrical systems. The original school building was built in the mid sixties and was remodeled and expanded in the mid eighties. The existing mechanical equipment and systems were, either, past the life cycle replacement age and are being replaced with newer technology and energy efficient systems, or are of newer vintage and are being refurbished. The building is approximately 100,000 square feet and has a pool. There are multiple existing fan rooms and Air Handling Units (AHU). Most of the AHU's are being replaced with Variable Refrigerant Flow (VRF) heat pumps and Energy Recover Ventilators (ERV) systems. Additional work in the BMS Remodel includes installation new building controls, motors, motor controls, new electrical service, replacement exhaust fans, the replacement of the domestic water system (piping and fixtures), the installation of fire life safety systems, computer network, clock and PA system.

The City and Borough of Sitka (CBS) published a Request for Qualifications (RFQ) for a qualified Commissioning Agent to commission the building mechanical and electrical systems at BMS. The Work includes commissioning the VRF Systems, Energy Recover Ventilators (ERV), Exhaust Fans, Hydronic Heating, Boiler Systems, Air Handling Units (AHU), Building Controls, Convectors, Equipment and Motor Connections, Unit Heaters, Domestic Hot Water System, equipment Testing Adjusting & Balancing, and to provide Owner Training for the proper operation and maintenance of the equipment.

The Commissioning Agent is the expert representing the Owner. The Commissioner works with the Contractors, Consultants, and Owner during the construction and installation of the building systems and equipment to ensure all systems are properly installed, calibrated, and operating at best capacity at project completion.

The Commissioner will perform the following tasks:

- 1) Develop Commissioning Plan as outlined in the commissioning specifications.
- 2) Review Submittals and O&M Manuals
- 3) Review Air/Water Balancing Reports

#### **Analysis**


The RFQ for a Commissioning Agent for the BMS Remodel was published in accordance with CBS and State of Alaska procurement requirements. There were four respondents to the RFQ. The qualifications and references for each respondent were checked and the selection committee unanimously chose the number one ranked respondent; Maiani Construction Services, Inc.

#### **Fiscal Note**

Fees for the Commissioning Work at BMS have been successfully negotiated. The BMS Remodel-2011 project funds total \$12.4 million, and include State 70% funding, CBS 30% funding, and bond proceeds. The construction contract is within its budget and there are sufficient project funds to award the contract to Maiani Construction Services, Inc. for the commissioning of the building systems at Blatchley Middle School.
