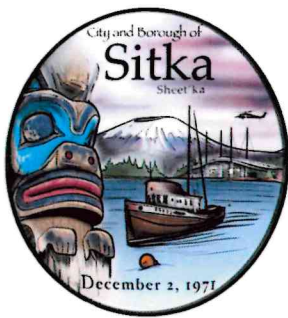


## **POSSIBLE MOTION**
