Sawmill Cove Industrial Park (SCIP) Bottled Water Rates

# **Background**

In May 2010, the SCIP Board of Directors discussed and recommended the establishment of public rates for raw water to be used for bottling at the SCIP. The Assembly approved the SCIP board's recommendations in June 2010. Please see attached memorandum dated 06/02/2010 for more background information.

The SCIP bottling water rate was set at comparable rates to other communities that sell water for bottling operations. The rate was set lower than the bulk water rate, as jobs would be created with a bottling production plant and that no water allocation would be guaranteed.

In November 2012, the SCIP Board recommended, and the Assembly approved to allocate 95% of the CBS's exportable water to True Alaska Bottling (TAB) in the 4<sup>th</sup> amendment to TAB's bulk water contract. Section 5.2 of the amendment limited how the CBS could sell the remaining 5% of the exportable water.

Section 5.2 Sitka will not enter into any agreement to sell water in bulk with the remaining 1,462 acre-feet of its bulk water allocation. Any sales of the remaining bulk water allocation will be limited to export in containers of a 20' container van or smaller. Sale of water bottled in City and Borough of Sitka is not subject to this restriction.

Since the implementation of the SCIP Bottling water rate, various ways have been envisioned to package and sell water. In the Director's opinion, clarification needs to be added to Sitka General Code (SGC) 15.05.625 concerning bottling water.

# **Current SGC 15.05.625**

- A. Water Service—Sawmill Cove Industrial Park.
  - 1. Unmetered treated water, domestic use: base rate, thirty dollars and eighty cents per unit, per month.
  - 2. Metered water: ninety-six dollars and thirty cents per month minimum.

- a. Treated water: one dollar and ninety-three cents per one thousand gallons.
- b. Treated water, fish processing use: one dollar and forty-five cents per one thousand gallons.
- c. Raw water for heating: sixty-seven cents per one thousand gallons.
- d. Raw water for industrial processing: ninety-six cents per one thousand gallons.
- e. Raw water for water bottling at Sawmill Cove Industrial Park: one dollar and sixty-nine cents per one thousand gallons.

## Proposed Change to SCG 15.05.625

- A. Water Service Sawmill Cove Industrial Park
  - 2.
  - E. Raw water for bottling at Sawmill Cove Industrial Park <u>in container</u> <u>sizes of five gallons or less</u>: one dollar and sixty-nine cents per one thousand gallons.
  - F. Raw water for bottling at Sawmill Cove Industrial Park <u>in container</u> <u>sizes greater than five gallons</u>: one cent per gallon.

# Recommendations

The SCIP Board recommends the CBS Assembly approve and adopted the proposed changes to Sitka General Code 15.05.625 as outlined above.

Water rates for commercial bottling operations

### Introduction

Currently the Sitka General Code (SGC) does not contain a rate for water to be used for commercial bottling operations. The purpose of this memo is to request the inclusion of such a rate into SGC 15.05.625.

## Background

Two separate entities have operated water bottling businesses at the Sawmill Cove Industrial Park. Both entities entered into purchase agreements to purchase raw water for bottling from the CBS. Both entities required a guaranteed allocation of water in their purchase agreement (400,000,000 gallons). The water rate set in the purchase agreement was \$5.00 per thousand gallons with a clause to increase over time to \$12.50 per thousand gallons. Both entities were not able to make their business models work and went out of business.

#### Cove Parters LLC

Cove Partners LLC (Cove) is the new owner of the water bottling plant located at the Sawmill Cove Industrial Park. Cove took over the business after True Alaska Bottling (TAB) went out of business in the fall of 2008. They are in the process of development a new business model to attempt to make the bottling operation profitable. Cove has requested a lower rate for purchasing raw water for bottling based off what other municipal water users are being charged. Cove does not require having a guaranteed allocation of water. They wish to be treated like any other municipal user of water.

The Sawmill Cove Industrial Park (SCIP) Board of Directors met with Cove representatives on May 25, 2010 to discuss water rates for bottling operations. Cove uses raw water for their bottling operation. The SCIP Board believed that the current rate set by SGC 15.05.625 for "raw

water for industrial processing" was too low to be used for a bottling operation as Cove will be reselling the water for a profit and not using the water for an ancillary purpose.

The SCIP Board recommended that a new subsection be added to SGC 15.05.625 to account for raw water to be used for commercial bottling. The SCIP Board recommends that the rate be based off the same rate used for "metered treated water" in SGC 15.05.625. That current rate is \$1.14 per thousand gallons with a \$57 monthly minimum and is set to adjust to \$1.30 per thousand gallons with a \$65 monthly minimum by the pending ordinance.

The proposed 14% increase in the water rates over the next few years was discussed with Cove. If future Assembly action approves the 14% increase annually, the rate for bottling operations would look as follows:

- 2012 Min cost \$74 or \$1.48 per thousand gallons
- 2013 Min cost \$85 or \$1.70 per thousand gallons
- 2014 –min cost \$96 or \$1.92 per thousand gallons
- 2015 min cost \$110 or \$2.20 per thousand gallons
