Subject:	Bear Attractive Nuisance Ordinance Revision
Date:	November 20, 2012

The Sitka General Code Chapter 9.24 entitled "Bear Attraction Nuisance" was reviewed by the Sitka Police Department, the Alaska Fish and Wildlife Troopers, and the bear work group. Two changes were recommended.

The first change recommended was to amend the amount of putrescible waste, to eliminate "More than one-half gallon" and change it to "Any amount" of any putrescible waste, including packaging or other surfaces to which the material is adhered;

The purpose of the change was to eliminate Police Officers having to measure the amount of waste.

The second of the issues is the mandated first warning in the ordinance. Officers will continue to give warnings it the situation calls for it. But the ordinance has been in place long enough; a mandatory warning is not needed at this point, and tends to limit the PD ability to enforce the ordinance.

The Bear Task Force believes changing these two items would allow us to more easily write citations and enforce the ordinance.

 - Current- BIHA has placed (5) 350 gallon dumpsters on Andrew Hope St.
 Each serves four households and replaces individual cans. Gravel pads were created for the larger cans, which have been secured to the ground.
 - Current- BIHA added one more 350 gallon can to serve Catherine Benson St and replace individual cans. BIHA will also retro fit all six 350 gallon cans and secure them to the ground.
 - Current- Public Safety Academy- replaced current dumpsters with (2) 350 gallon retro fitted cans, secured to the ground.





Cascade Creek Road

- Gradual replacement if old 95 gallon cans with newer retro-fitted cans starting from the top end of the road, working downhill. In process.
- o Placed several 350 Bear Resistance cans upon request from residents.

 Mill St., Shotgun Alley, others
- 3. Bear Stats: 2012 has more calls than were anticipated but is not an abnormally high year for bear activity.
