4. ENACTMENT. In accordance with Section 11.10 (a) of the Charter of the City and Borough of Sitka, Alaska, the Assembly hereby makes the following supplemental appropriation for the budget period

FISCAL YEAR 2026 EXPENDITURE BUDGETS GPIP CAPITAL PROJECT FUND Fund 780– Marine Vessel Haul Out and Shipyard Project #90931: Increase appropriations by \$150,000 funded from the Southeast Alaska Economic Development Fund and \$495,250 funded from General Fund Working Capital. **GPIP FUND** Fund 270– GPIP Operations: Increase appropriations by \$70,000 funded from the GPIP Working Capital

49 50 Additional capital funding is required to support completion of Phase I of the Marine Vessel Haul Out and Shipyard project prior to the commencement of operations by Highmark Marine Fabrication.
