VAR 25-01) 11 12 1. **CLASSIFICATION.** This ordinance is not of a permanent nature and is 13 not intended to become a part of the Sitka General Code (SGC). 14 2. 15 **SEVERABILITY.** If any provision of this ordinance or any application to 16 any person or circumstance is held invalid, the remainder of this ordinance and 17 application to any person or circumstance shall not be affected. 18 19 3. PURPOSE. The purpose of this ordinance is to authorize the 20 Administrator to contract with the State of Alaska Office of Administrative Hearings 21 ("OAH") to serve as Board of Adjustment due to a majority of the sitting Assembly 22 recusing themselves from serving as the Board of Adjustment because of conflicts of 23 interest and/or ex parte communications and/or actual or apparent bias. 24 25 **ENACTMENT.** NOW, THEREFORE, BE IT ENACTED by the Assembly 26 of the City and Borough of Sitka, upon finding as follows: 27 28 (1) The Assembly does not meet the quorum requirements to act as the 29 Board of Adjustment in this matter because a majority of the Assembly 30 members have recused themselves due to conflicts of interest and/or ex parte 31 communications and/or actual or apparent bias. 32 33 (2) The Sitka General Code does not have any provisions for delegating the 34 Assembly's powers to serve as the Board of Adjustment. 35 36 (3) It is in the interest of justice and the parties' due process rights that an 37 appropriate body hears the appeal of the Planning and Zoning Commission's 38 denial of a variance for a cell tower requested by Tlingit and Haida, Tidal 39 Network, (P&Z No. VAR 25-01) by referring this matter to the Office of 40 Administrative Hearings. 41 42 (4) Per AS 44.64.055 the Office of Administrative Hearings is an appropriate 43 body and may contract with municipalities to hear appeals. 44 45 Thereby, the authority of the Assembly to act as the Board of Adjustment for hearing the

appeal of VAR 25-01 is delegated to the Office of Administrative Hearings.
