NOW, THEREFORE, BE IT RESOLVED by the Assembly of the City and Borough of Sitka that the City and Borough of Sitka supports the project entitled ANB Harbor Replacement and agrees, subject to available Legislative Funding and Selection by DOT&PF, to enter into a grant agreement with the State of Alaska, Department of Transportation and Public Facilities for a Municipal Harbor Facility Grant. Subject: ADOT-PF Municipal Harbor Facility Grant Application for ANB Harbor

#### Background:

ANB Harbor (ANB) was originally constructed in 1956. Since that time, numerous repair and replacement projects have been undertaken at the facility. A condition assessment of ANB was completed by Tryck Nyman Hayes, Inc. (TNH) in June 2008. TNH recommended that ANB be replaced in its entirety. A cost estimate completed in June 2011 by PND Engineers, Inc. estimated the replacement cost of ANB to be approximately \$8,500,000.

The Harbor Department has budgeted \$150,000 during the 2012 fiscal year for a consultant to complete a Harbor Master Plan. This report will evaluate the remaining useful life of the entire harbor system infrastructure, prioritize future capital projects, and help provide guidance on funding required to maintain the current level of service.

### Analysis:

The Alaska Legislature established a 50/50 matching grant program, called the Municipal Harbor Facility Grant Program, in 2006 to provide financial assistance to municipal owned harbors. This grant program is funded on an annual basis at the discretion of the legislature. The City and Borough previously submitted grant applications for ANB Harbor for FY2010 and FY2011, however these applications were unsuccessful.

ANB Harbor Replacement is currently the highest priority proposed harbor infrastructure capital improvement project for the CBS Harbor Department. Securing grant funding for this project would allow the City and Borough to replace this aging facility before it reaches the end of its residual life for half the cost of a new facility. A new resolution of support from the Assembly would serve to strengthen the application, providing the City and Borough the best possible chance of securing funding for this project.

#### Fiscal Note:

When the City and Borough's required 50/50 local match is required in the future, it is anticipated that such funds will be provided either from the reserve working capital of the Harbor Fund, or through borrowing from other municipal sources such as the Southeast Alaska Economic Development Fund.

#### Recommendation:

Authorize the Administrator to submit an ADOT-PF Municipal Harbor Facility Grant Application for the replacement of ANB Harbor.
