This ordinance is of a permanent nature and is intended 13 to become a part of the Sitka General Code ("SGC"). 14 15 2. **SEVERABILITY.** If any provision of this ordinance or any application to any 16 person or circumstance is held invalid, the remainder of this ordinance and application to 17 any person or circumstance shall not be affected. 18 19 **PURPOSE.** The Tourism Commission ("Commission") has recommended 20 these proposed amendments to the SGC regarding Commission membership and duties. 21 22 In particular, the Commission proposes that assigned membership regarding various user groups is no longer needed. This will make it easier to fill vacant positions on the 23 Further, the addition of signage duties in SGC 2.66.050 reflects current 24 25 tasks undertaken by the Commission in assisting municipal staff and contractors with 26 directional signs and interpretative signs to inform visitors and local citizens. 27 4. **ENACTMENT.** NOW, THEREFORE, BE IT ENACTED by the Assembly of 28 the City and Borough of Sitka that SGC 2.66 entitled "Tourism Commission," at Section 29 2.66.010 "Establishing-Membership-Terms," and Section 2.66.050 "Duties," is amended 30 to read as follows (new language underlined; deleted language stricken): 31 32 33 2.66.010 Established—Membership—Terms. 34 35 A.
