In addition to my personal experience, my career in public service has required objective decision-making, accountability, and working within structured governance systems—skills that translate directly to committee work.

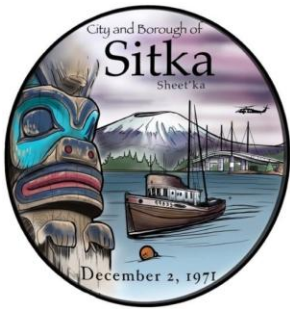
I would welcome the opportunity to contribute to the City in this capacity and to support prudent, disciplined management of public funds.
