Proclamation

Walk Friendly Community

WHEREAS, improving Sitka's walking experience by applying for a Walk Friendly Communities designation was selected as one of the three community wellness goals of the 2012 Sitka Health Summit; and

WHEREAS, walking and hiking are recognized as healthy activities that reduce the risks of obesity, diabetes, heart disease, and some forms of cancer, improve mental health, and provide many other health benefits; and

WHEREAS, research has shown that walkable communities have stronger local economies and are friendlier to visitors, who can better experience the flavor of the town by meeting a wide variety of local residents as they walk the streets; and

WHEREAS, walkable communities are better for the environment as people choose to leave their cars at home, which reduces the rate of air pollution and fuel use in the community; and

WHEREAS, Alaska has the highest rate of adult commuters who walk in the country at 8.0 percent, and Sitka has a walking commuting rate of 11.32 percent, which is well above the national average of 2.9 percent for walking commuters; and

WHEREAS, applying for a Walk Friendly Communities designation provides a framework to help communities learn how to provide safe accommodation for walking and encourage its residents to walk for transportation, health, and recreation; and

WHEREAS, the City and Borough of Sitka has more than 52 miles of hiking trails and an additional 11.7-plus miles of sidewalks and bike paths developed by the City, the Alaska Division of Parks and Outdoor Recreation, the Alaska Department of Transportation and Public Facilities, the U.S. Forest Service, the National Park Service, the non-profit group Sitka Trail Works, and other groups within its boundaries; and

WHEREAS, the City and Borough of Sitka recognizes the importance of walking, cycling, and motorist education and safety programs geared toward sharing the roads and sidewalks; and

WHEREAS, the City and Borough of Sitka supports the efforts of Walk Sitka, a group formed after the Sitka Health Summit to work on improving and recognizing Sitka's walking experience by applying for a Walk Friendly Communities designation.

NOW, THEREFORE, BE IT RESOLVED the Assembly of the City and Borough of Sitka supports the work being done by Walk Sitka to help Sitka earn recognition as a Walk Friendly Community; and hopes the citizens of the community continue to be supportive in order to financially sustain these goals.
