

Project Description Overview:

The Salvation Army Alaska Sitka Corps requests \$20,000 in grant funds in the Human Services category of the City and Borough Annual General Fund Grants.

We request these funds to support the growing food pantry and soup kitchen needs of Sitka and to build capacity for our Food Assistance programs. This General Fund request will be used to purchase 1) food for the Food and Soup Kitchen Pantries at a bulk rate 2) a small amount of personal hygiene items for the pantries, and 3) two new 20 cubic foot freezers.

The Salvation Army Sitka Corps will manage the project funds, including purchase and distribution of the food and personal hygiene items locally and purchase and maintenance of the freezers. We are proud to have been serving Sitkans for over 100 years! Our food assistance programs have been active since 2008, and we look forward to continuing to build on this excellent and important work.

The Sitka Corps Food Pantry and Soup Kitchen assists anyone who qualifies for assistance from the Sitka Tribe of Alaska (STA), and we are also a Federal TEFAP (The Emergency food Assistance Program) distribution agency. Our clients are the members of our community who are disabled, lack income, or who are of senior age. We also serve working families when their income is just above the guidelines for Food Stamps but within the income guidelines to receive assistance.

Items purchased through this grant for distribution will be distributed during regular Food Pantry and Soup Kitchen hours, Monday through Friday, and also Thanksgiving and Christmas as needed. In our current program, the KIFW drive for food and funds allow for food to be distributed starting in November, and food items not distributed during the holidays continue to be distributed until they are gone. We find that the food items that are left over from the food drive begin to diminish by April. In April, we begin to purchase items, but because of budget restraints we are not able to provide some of the staple items such as cereal. Funds from this grant request would not only ensure our ability to remain open throughout the year, but they would also allow us to purchase items most needed by the members of our community.

Expected Outcomes:

Having the support of our City and Borough will mean our ability to address the hunger needs of all Sitkans and remain open with a full food pantry all year. It will also grow our capacity with the addition of the two freezers and allow us to work with area businesses and other organizations to leverage funds. We will continue to measure the number of Sitkans served in the food pantry and soup kitchen through our internal statistical program. We will also track food donations and the

utilization of the freezer in allowing us to accept large quantities of frozen food.

Our mission for this program is to meet the food needs and reduce hunger in our community. We look forward to seeing the impact reaching our mission will have on the community. By being able to assist clients with food, we enable them to stay healthier physically and reduce stress mentally. A head of household may no longer need to make the tough decision between either purchasing food for the month or being able to pay their utility account and stay warm. In some cases they won't have to choose between paying for food and paying for medication. The relief of these choices is hard to measure in a tangible way, but the long-term qualitative effects are great.

The Salvation Army Sitka Corps measures our efforts to provide food and emergency services to those in need. As a result of this grant, we expect to increase the number of Sitkans served with food assistance in 2015. In doing so, we may also observe a decrease in the number of clients seeking assistance with utility or medication costs over time.

Our monthly accounting of numbers of persons served in the Soup Kitchen will be tallied. As will be described below, we are seeing an increase in numbers each month, and on a yearly average. Our benchmarks for each month will be measured against previous numbers, and we will use these to project future needs and assess our budget capacity.

Statement of Need:

Serving the hungry of our community is one of the most basic human services possible. To feed a hungry child, senior citizen, person lacking income, is to bring that person's physical need to a place where she or he can attend to other needs of health, well-being, learning, employment, and so many other areas of life. It is essential to survival, and an essential service in our community. By assisting in a way that can be counted on, with a healthy budget for ongoing essential food items, we decrease stress in our clients served and allow them the freedom to address other needs.

In 2006 the City of Sitka Comprehensive Plan was written with goal 2.10.2: "to create a system to provide adequate food to all residents, which incorporates a coordinated needs-driven delivery system, which will complement the existing eligibility-driven programs." We are seeing a growing need for food assistance in our community over the past few years. Community members utilizing our Soup Kitchen and Holiday Meal Programs are increasing, and we are unable to adequately supply our Food Pantry due to these increased needs.

Our soup kitchen served 435 persons per month from October 2011 to September 2012. During the same time period of 2012-2013, we served 577 persons per month. In the period of time from October 2013 to the end of July 2014, we have served 661 persons per month, and with 771 persons served in June of 2014 and

890 in July, that average will increase even more by the end of September.

We see an increase in our Holiday meal program as well, though not as drastic. In 2013 our Christmas meal program alone fed 115 families - 391 persons, for a total cost of \$17,823.91.

Funding from this grant request will leverage more funds, and we look forward to sharing with the Community of Sitka a goal to match the City and Borough funds with the donations of the community! It is also with this grant that we can go to other organizations and businesses in our community to show the need, the city and borough support, and the support of our community members to request funds for larger projects. If we show that our city and our community members support our work, we can show the importance of the food assistance program and continue to address the food needs of our community.

Organizational Capacity:

The Salvation Army Alaska Sitka Corps provides food assistance services for Sitkans Monday through Friday. We distributed holiday meals to 205 families in 2013. As noted above, we see a growing need for food assistance in our community and are uniquely situated to meet that need. Growing the existing food pantry, with the addition of two freezers, will build our capacity to store frozen food donations, such as salmon. With the help of many volunteers, our two Pastors/Officers will be able to distribute the extra food and hygiene items with their current duties.

We are grateful for a great deal of community support in Sitka, and we respectfully request this grant funding to match the donations of community members themselves. In November of 2013, our main KIFW food and funds drive generated \$11,000 in funds and 11,000 pounds of food. Using an average of \$1.50 per pound, we estimate the value of those food donations at \$16,500 for a total fundraising effort of \$27,500. The addition of \$20,000 from the City and Borough of Sitka would allow us to keep our Food Pantry open year round and also allow us the opportunity to accept large donations of items such as frozen fish or game. In 2013, we also received a generous gift of \$10,000 from the Bob Wyman Living Trust and hundreds of individual donations from our community members.

Sitka Corps is currently working to revitalize our Community Advisory Board and is recruiting membership. We plan to have our first board meeting in October 2014. Although we do not have a board we are an active part of the Easter Group board.
