A taxpayer who fails to file a return as provided in Section 4.12.050(A) shall be subject to a fee of one hundred dollars for the cost of the Assessor's preparation of a valuation based on information available or obtained by the Assessor for the taxable property as allowed under Section 4.12.030 (also referred to as "forced filing"). The taxpayer shall be notified of the fee as of the date of mailing of business property and personal property assessment notices." Ordinance 13-29
