Article 13.03, entitled "Property Tax Limit," by raising the property tax millage rate limit from 6 mills to 8 mills. 24 25 26 4. ENACTMENT. NOW, THEREFORE, BE IT ENACTED by the Sitka 27 Assembly that the Charter, Article 13.03, entitled "Property Tax Limit," is amended to 28 read as follows (new language underlined; deleted language stricken): 29 30 31 32 **HOME RULE CHARTER** 33 ARTICLE XIII 34 **TAXATION** 35 36 37 38 **Section 13.03 Property Tax Limit.** 39 The property tax levy shall not exceed six eight-tenths (0.006) (0.008) of one per cent (6 40 41 mill) (8 mills) of the assessed valuation of the property to be taxed. The voters may 42 raise this limit by an affirmative vote of the majority of the voters participating in a special or regular election. 43
