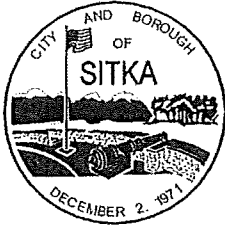

Dear Mr. Martinsen,

We have completed our evaluation of the Bidder Qualifications and additional information submitted by Tamico, Inc. for the O'Connell Bridge Lightering Facility Pile Replacement Project. Your submittal contains material omissions rendering your bid non-responsive.

- Bidder Qualifications (1.2A) require the Permitting Specialist to list at least two previous Incidental Harassment Authorizations (IHA) successfully obtained for marine projects of similar scope and consideration within the past 5 years. Your submittal did not include this information. A follow up with your proposed Permitting Specialist confirmed that they have never obtained an IHA.
- Bidder Qualifications (1.2C.4) require insurance documents that demonstrate the Bidder's ability to obtain insurance as specified in the General Conditions and Supplementary Conditions. Your submittal did not include this information.

Furthermore, after careful consideration, Tamico has been determined to be a non-responsible bidder due to your failure to strictly comply with local, state, or federal permits, or any portion thereof, on the Sitka Transient Float Project as outlined in the Bidder Qualifications (1.1J).

Under the City and Borough of Sitka's Procurement Bid/Proposal Evaluation Policy, the Administrator is the appellate authority with regard to whether a bid/proposal is responsive. A bidder may seek subsequent Assembly review in accordance with City and Borough of Sitka Standard Specifications Section 10.03, Article 3.1.
