17 18	3. PURPOSE. The purpose of this ordinance is to amend Chapter 15.04 of the Sitka
19	General Code to increase wastewater service connection and wastewater treatment fees.

At the time the applicant files for a connection permit where no service previously existed; or, if the applicant is filing for a change in service connection, or size, or to serve a new structure, the applicant shall submit with the application the service connection charge of seven hundred forty sixty dollars. This charge is to cover the costs to the CBS of locating the stub-out from the sewer main (if available), inspection of the sewer service line, administrative costs, and
41 42 43	permit fees. Upon approval of the connection, the property owner may proceed in accordance with the provisions in Section 15.04.130.
43 44 45 46 47	B. The connection of a sewer service line to a sanitary sewer main located in the state highway right-of-way may be subject to state utility permit fees. Said fees shall be paid by the property owner.
