10 11 12	<b>1. CLASSIFICATION.</b> This ordinance is of a permanent nature and is intended to become a part of the Sitka General Code.
13	
14 15 16	<b>2. SEVERABILITY.</b> If any provision of this ordinance or any application to any person or circumstance is held invalid, the remainder of this ordinance and application to any person or circumstance shall not be affected.
17	
18	3. PURPOSE. The purpose of this ordinance is to maintain Sitka's 37 year
19	participation in the National Floodplain Insurance Program (NFIP). FEMA will adopt
20	an updated Flood Insurance Rate Map on August 1, 2019 and to remain compliant
21	with the program Sitka must adopt an updated ordinance and associated regulations
22	prior to that date. Participation in the NFIP provides citizens of Sitka the availability
23	of federally backed loans, grants, and disaster assistance along with making flood
24	insurance available to all property owners in Sitka.
25	A ENACTMENT NOW THEREFORE RE IT ENACTED by the Assembly of the City
26 27	<b>4. ENACTMENT.</b> NOW, THEREFORE, BE IT ENACTED by the Assembly of the City and Borough of Sitka that the Sitka General Code Title 20, be amended by updating chapter
28	20.04, entitled "Floodplain Management" to read as follows (deleted language stricken, new
29	language underlined):

53 54 20.04.005 Statutory Authorization. 55 In Alaska Statute Title 26, the Alaska State Legislature has delegated the responsibility to each community to adopt floodplain management regulations designed to promote the 56 57 public health, safety, and general welfare of its citizenry, Therefore, the assembly of 58 the city and borough of Sitka does ordain as follows: 59 60 20.04.010 Purpose. A. Flood hazard areas within the city and borough of Sitka are subject to periodic floodwater 61 62 inundation which may result in a loss of life and property, pose health and safety hazards, 63 commerce and governmental services disruption, extraordinary public expenditures for flood 64 protection and relief, and impairment of the tax base. All of these consequences adversely 65 affect the public health, safety, and general welfare. It is the purpose of this chapter to minimize loss due to flooding conditions by: 66 67 68 1. Restricting or prohibiting structures and uses that are dangerous to health, 69 safety, or property when flooding occurs, or which increase erosion, flood heights 70 or flow velocities: 71 72 2. Requiring structures vulnerable to floods to be consistent with flood protection 73 or floodproofing, including public facilities; 74 75 Controlling fill, grading, dredging, and other development which may increase 3. 76 flood damage; 77 78 4. Reducing the financial burdens imposed on the community, government, and 79 individuals by rescue and relief efforts associated with flooding by providing sound 80 development of areas of special flood hazard; 81 82 5. Ensuring potential buyers of real property are notified if property is in a special 83 flood hazard area; and 84 85 Ensuring those who occupy the areas of special flood hazards assume 6. 86 responsibilities for their actions. 87 88 Areas within the city and borough of Sitka have been found to be potentially flood prone, Β. 89 as defined by Section 201 of the Federal Flood Disaster Protection Act of 1973. Therefore, the 90 municipality chooses to join the National Flood Insurance Program to make flood insurance and

federal and federally regulated financial assistance available to the residents within the flood
 hazard areas. To do so, the municipality must meet the requirements for participation in the
 National Flood Insurance Program.

#### 95 **20.04.020 Definitions.**

A. "Area of special flood hazard" means the land in the floodplain within the jurisdiction of the
city and borough of Sitka subject to a one percent or greater chance of flooding in any given
year. Such an area is designated on the Flood Insurance Rate Map for the city and borough of
Sitka (FIRM) as including the letter "A" or "V." The term "special flood hazard" for the purposes
of this chapter is synonymous with the phrase "area of special flood hazard."

B. "Coastal high hazard area" means the area subject to high velocity waters due to wind, tidal action, storm, <u>seismic</u>, tsunami or any similar force, acting singly or in any combination resulting in a wave or series of waves of sufficient magnitude, velocity or frequency to endanger property and lives. <u>These areas are designated on the FIRM by including the letter "V".</u>

107 C. "Flood hazard area" includes all the area within the city and borough of Sitka subject to a 108 one <u>percent or greater chance of flooding in any given year-hundred-year flood</u> as delineated on 109 the FIRM. "Flood hazard area" includes the coastal high hazard area, where applicable. The 110 municipality makes no guarantee that structures located outside the flood hazard area will not 111 be subjected to flooding.

112

D. "Flood Insurance Rate Map" or FIRM means the official map of the Federal Insurance
 Administration that has delineated both the areas of special flood hazards and the risk premium
 zones applicable to the city and borough of Sitka.

E. "Floodproofing" means any combination of structural and nonstructural additions, changes,
or adjustments to structures that reduce or eliminate flood damage to real estate or improved
real property, water and sanitary facilities, structures and their contents.

F. "Floodway" means the channel of a river or other watercourse and the adjacent land areas that must be reserved in order to discharge the base flood without cumulatively increasing the water surface elevation more than one foot. The term is also referred to as the "regulatory floodway."

126G. "NAVD 88" means the North American Vertical Datum of 1988, the vertical control datum127established in 1991 by the minimum-constraint adjustment of the Canadian-Mexican-United128States leveling observations.

G. "One-hundred-year flood" means a flood of a magnitude which can be expected to occur on the average of once every one hundred years. It is possible for this size flood to occur during any year. The odds are one to a hundred that this size flood will occur during a given year, but there is a one percent chance that a flood will occur each year. Statistical analysis of available streamflow or coastal storm records, or analysis of rainfall and runoff characteristics of the watershed, or coastal topography and storm characteristics are used to determine the extent and depth of the one-hundred-year flood.

H. "Structure" for floodplain management purposes means a walled and roofed building, and
 includes mobile homes, manufactured homes, and gas and liquid storage tanks or containers
 that are principally above ground.

142 I. "Substantially improved" means any remodeling, repair, reconstruction or improvement of a
143 structure, the cost of which equals or exceeds fifty percent of the fair market value of the
144 structure either: (1) as such value exists before the improvement is started, or (2) as such value
145 existed before the damage occurred.

## 147 **20.04.030** Reference to other codes.

148 Applicants requesting permits subject to this chapter are cautioned to refer to Chapter 6.12,

149 Mobile and Manufactured Homes and Mobile and Manufactured Home Parks; Title 19, Building

- and Construction; and Title 21, Subdivisions; in the Sitka General Code for other specificapplicable provisions and regulations.

### 153 **20.04.035 Interpretation—Disclaimer of liability.**

154 A. In the interpretation and application of this chapter, all provisions shall be liberally 155 construed in favor of enforcement and considered minimum requirements.

B. In the interpretation and application of this chapter, all provisions shall be deemed as not
limiting nor repealing any other powers granted under municipal, state or federal laws.

C. This chapter is not intended to repeal, abrogate or impair any existing easements,
 covenants, or deed restrictions. However, if the provisions of this chapter and another provision
 of the Sitka General Code, ordinance, easement, covenant or deed restriction conflict or
 overlap, whichever imposes the more stringent restrictions shall prevail.

165 The degree of flood protection required by this chapter is considered reasonable for D. 166 regulatory purposes and is based on scientific and engineering considerations. Larger floods 167 can and will occur on rare occasions. Flood heights may be increased by manmade or natural 168 causes. This chapter does not imply that land outside the areas of special flood hazards or uses 169 permitted within such areas will be free from flooding or flood damages. This chapter shall not 170 create liability on the part of the city and borough of Sitka or FIMA officials or employees, for any 171 flood damages that result from reliance on this chapter or any administrative decision lawfully made under its provisions.

## 174 **20.04.040** Implementation.

A. The building official or designee shall administer and implement the provisions of this
 chapter, and shall be responsible for maintaining for public use and inspection appropriate
 records and information relevant to implementation of this chapter. Such records and
 information shall include, but not be limited to:

1. Actual elevations, in relation to <u>NAVD 88mean sea level</u>, of the lowest floor, including basement, of all new or substantially improved structures located in the flood hazard area, and whether or not such structures have basements;

2. Actual elevations, in relation to <u>NAVD 88</u> mean sea level, of all new and substantially improved floodproofed structures and the required floodproofing certifications;

200	1. Review all permit applications for development in the flood hazard area for
201	compliance with the provisions of this chapter, and to determine that all necessary
201	permits have been obtained from local, state or federal governmental agencies.

204	<ol><li>Interpret the exact locations of boundaries of the areas of special flood hazard</li></ol>
205	and regulatory floodway. If there appears to be a conflict between a mapped
206	boundary and actual field conditions, the Building Official shall determine and
207	interpret the documents. A person contesting the interpretation shall be given a
208	reasonable opportunity to appeal the interpretation, as provided for in the Sitka
209	floodplain regulations. When base flood elevation data has not been provided, the
210	building official shall obtain, review and reasonably utilize any base flood elevation
211	and floodway data available from any federal, state, municipal, or any other source
212	in order to administer the provisions of this chapter.
213	
214	20.04.050 Flood hazard district.
215	A. <u>The special flood hazard areas identified by the Federal Insurance Administrator in a</u>
215	scientific and engineering report titled "The Flood Insurance Study (FIS) for The City and
217	Borough of Sitka, Alaska" dated August 1, 2019 with accompanying Flood Insurance Rate Maps
218	(FIRMs) dated August 1, 2019 are hereby adopted by reference and declared to be a part of this
219	ordinance. The FIS and FIRM panels are on file at 100 Lincoln Street, Sitka Alaska, in the
220	Building Department Office. A flood hazard district is created for the city and borough of Sitka,
221	and shall be defined in its territorial extent by the following reports and maps:
222	
223	1. Flood Insurance Study (FIS), Number 02220CV000B 02220CV000A, effective
223	date <u>August 1, 2019</u> September 29, 2010, prepared for the city and borough of
224	
	Sitka by the Federal Insurance and Mitigation Administration (FIMA) and Federal
226	Emergency Management Agency (FEMA).

228	<ol> <li>Flood Insurance Rate Map (FIRM) Number <u>02220CIND1B</u> 02220CIND0A,</li> </ol>
229	effective date <u>August 1, 2019</u> September 29, 2010, prepared for the city and
230	borough of Sitka by the FIMA and FEMA.

232	B. Current editions of each of the maps and reports listed above are made a part of this
232	chapter, incorporated by reference. Subsequent maps and reports prepared by the FIMA or the
234	city and borough of Sitka delineating the flood hazard district, floodway and floodplain areas
235	within the city and borough of Sitka shall become part of this chapter upon publication. A copy of
236	the maps and reports cited in this subsection are available at the public works department.
237	
238	C. Sitka floodplain regulations, adopted under Section 20.04.060, shall govern construction
239	and development within the areas of special flood hazard, and are incorporated by reference
240	under this chapter.
240 241	
	D In each any structure is constructed or substantially improved in violation of this charter
242	D. In case any structure is constructed or substantially improved in violation of this chapter,
243	the city and borough of Sitka, in addition to other remedies, may institute any proper actions or
244	proceedings necessary, including enjoining of connections to public utilities, to restrain, correct
245	or abate such violations.
246	
247	E. The municipal administrator of the city and borough of Sitka is authorized to enter into

contracts and agreements with other government entities for the purpose of implementing the
 provisions of this chapter.

F. The municipality must notify the state coordinating agency and FIMA prior to altering or
 relocating any watercourse. Any such alteration or relocation must maintain the flood-carrying
 capacity of the watercourse.

G. Nothing in this chapter shall be construed as applying to any structure existing prior to the effective date of the ordinance codified in this chapter, unless they are substantially improved after the effective date.

# 258259 20.04.060 Regulations.

260 Sitka floodplain regulations shall be adopted by the assembly to implement the provisions of this 261 chapter, and shall be incorporated by reference under this chapter.
