The Assembly's intent is to promote understanding and compliance with the code and to be business friendly by reducing the cost of doing business in Sitka. 4. ENACTMENT. a. Name and address of the purchaser or purchaser's designee;

b. Signature or electronic signature of the purchaser or purchaser's designee;

c. Expiration date as appropriate for the authorized exemption; and

d. City and borough of Sitka's authorized exemption number.

3. For all others:

a. Name and address of the purchaser;

 b. Expiration date as appropriate for the authorized exemption; and

 c. City and borough of Sitka's authorized exemption number.

An exemption certificate <u>issued by the city and borough of Sitka and</u> executed by a purchaser or lessee must <u>either (1)</u> be in the possession of <u>and presented by the purchaser or lessee or (2) the valid authorized exemption number provided to the seller or lessor by the <u>purchaser or lessee</u>, at the time that an exempt transaction occurs.</u>

 B. An exemption certificate must contain the information and be in a format prescribed by the city and borough of Sitka.

C. If the seller or lessor accepts an exemption certificate or a valid authorized exemption number and believes in good faith that the purchaser or lessee will employ the property or service transferred in an exempt manner, the properly executed exemption certificate or valid
