## RE: Letter of interest in serving on the Climate Action Task Force

Dear Mayor Eisenbeisz and Assembly Members,

As long as carbon dioxide levels in the Earth's atmosphere continue to increase, then so will the Earth's average temperature at its surface and in its oceans.

The correlation between  $CO_2$  and temperature has been understood by science for over a hundred years. It is as close to being a law of nature as the law of gravity. Some people argue that the current rise in atmospheric  $CO_2$  is due to natural variability. But scientists now universally recognize that it is certainly human caused, primarily due to the combustion of fossil fuels. Thus, humans must take on the responsibility of addressing this problem, otherwise temperatures will continue to rise to the point where the life support systems which have made our modern civilization possible will begin to fail us.

This is not to say that human survival is at imminent risk. We are, after all, an incredibly resourceful species, and we may discover temporary technological fixes to help keep the planet from overheating for a while. But the solution to the problem, ultimately, lies in stabilizing and reversing the accumulation of  $CO_2$  in the atmosphere. And the most effective means of achieving this objective is for humans to phase-out the burning of fossil fuels as quickly as possible.

Individual people around the world, through our individual actions, can only hope to have a minor influence on the trend of global warming, or on the climate changes that it triggers. So, it has become clear to governments on every continent that they must play a leading role in developing and implementing meaningful carbon emissions reduction plans. That's what the Paris Plan was all about. That is why President-elect Biden is advocating an aggressive climate and clean energy agenda.

Communities like Sitka, which currently depend heavily on diesel for barge deliveries and commercial fishing, gasoline for our cars and jet fuel for trips off-island, must develop strategies for dealing with major changes to our normal operating procedures. Because major changes are coming, whether we want them to or not. And if we don't get ahead of these changes then they will simply overtake us. To quote Will Rogers: "Even if you're on the right track, you'll get run over if you just sit there."

I'd like to serve on the Climate Action Task Force to help this community plan for a new clean energy future.
