I am writing to express interest in serving on the Climate Action Task Force. When the last task force published the Climate Action Plan I had just graduated from Sitka High. I feel lucky to have grown up in Lingít Aaní, in a place where the complex connections between humans and natural systems are so evident and valued. I feel even luckier to be a member of a community that is committed to combating climate change through emissions reductions, mitigation, and adaptation.

I could contribute effectively to this task force because of my academic background and my experience with collaborative problem solving. During my undergraduate and graduate programs at Stanford I studied climate science, climate change impacts, earth systems, building systems, and climate change action planning for coastal cities. As part of my undergraduate major in engineering, I learned about sustainable building practices and clean energy technologies. As a design consultant with MRV Architects I had the opportunity to work on the Blueprint Downtown project to collect community input on long-term planning for the Juneau downtown area.

More recently, while training to become a science teacher, I had the opportunity to study the relationship between western science and Indigenous knowledge systems. The in-depth knowledge of natural systems gained by Alaska Native peoples through generations of living closely with the land is invaluable to responding to our current climate crisis. Moreover, Lingít environmental philosophies and values could help guide our actions as we make decisions about living with the land today. I would like to be part of a diverse task force that listens to the community and works together to find a way forward.

I believe the Climate Task Force has an incredibly important mission. Our community is already experiencing the effects of climate change. Whatever action we do or do not take in response will have long lasting impacts. We need to plan ahead to ensure the best possible future for our community and ecosystems. It is time to evaluate and update the previous climate action plan, and to set new goals and initiatives for sustainable community development.
