MEMORANDUM

Background

Part of the Sitka Animal Shelters mission is to help control the pet population by spaying and neutering all animal that are surrendered and/or abandoned to the Shelter and in order to do that we must pay the vets.

<u>Analysis</u>

Every year the shelter gets an influx of kittens in the spring, all requiring fixing and vaccinating but this last year (2020) a large number of kittens and cats were turned in throughout the summer and into fall, therefore depleting the funds. We are requesting monies to be moved from the Animal Shelter Donation (ADON - current balance \$75,000) fund to Fund 113-Pet Adoption Fund in anticipation for the 2021 kitten season we are now entering to pay for spays, neuters and vaccinations. These funds will also cover the cost of healthcare for the large number of adult cats being turned in from hoarding situations.

Fiscal Note

The supplemental appropriation will increase budgeted expense by \$10,000 in the Pet Adoption Fund.

Recommendation

Pass ordinance 2021-05 to increase the Pet Adoption Fund to cover the healthcare costs associated with the surrendering and abandoning of animals.

ORDINANCE NO. 2021-05 AN ORDINANCE OF THE CITY AND BOROUGH OF SITKA MAKING SUPPLEMENTAL APPROPRIATIONS FOR FISCAL YEAR 2021 (Pet Adoption Services: Veterinary Services)

BE IT ENACTED by the Assembly of the City and Borough of Sitka, Alaska as follows:

1. **CLASSIFICATION.** This ordinance is not of a permanent nature and is not intended to be a part of the Sitka General Code of the City and Borough of Sitka, Alaska.

2. **SEVERABILITY.** If any provision of this ordinance or any application thereof to any person or circumstance is held invalid, the remainder of this ordinance and application thereof to any person and circumstances shall not be affected thereby.

3. PURPOSE. The purpose of this ordinance is to make a supplemental Operations appropriation for
 FY2021.

4. ENACTMENT. In accordance with Section 11.10(a) of the Charter of the City and Borough of
 Sitka, Alaska, the Assembly hereby makes the following supplemental appropriation for the budget period
 beginning July 1, 2020 and ending June 30, 2021.
